

Sexual Exploitation Continuum (Brackenridge, 1997)



Sexual Discrimination: Defined as "chilly climate" (institutional) Sexual Harassment: Defined as unwanted attention (institutional and personal) Sexual Abuse: Two types are hostile environment or quid pro quo (personal)

Federal Laws

Title VII of the Civil Rights Act of 1964 Title IX of the Education Amendments of 1972 Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act

Mandatory Reporter: individual that is likely to "witness or receive reports of sexual harassment" are obligated to report anything witnessed or told to Title IX coordinators
